1. Roll Call

2. Approval of the Agenda

2.1. The Board of Directors Agenda of December 16, 2021 was approved as circulated.

3.1. The minutes of the November 23, 2021 Regular Meeting of the Board of Directors were approved unanimously.

4. President's Report – David Bissell, President & CEO

4.1 Safety (November)

- 4.2 Availability and Reliability:

 - 2021 YTD = 1.17; 2020 YTD = 0.91
- 4.3 Efficiency
 - 4.3.1 Net Plant Heat Rate Month = 9,075; 2021 YTD = 9,276
 - 4.3.2 Peak Demand (MW) Month = 75.2; 2021 YTD = 75.2
- 4.4. Residential Rates
 - 4.4.1 December 2021 = \$0.358/kwh up \$0.002 from November

- 4.5 2021 Year End Highlights
 - 4.5.1 With the AES PMRF solar-plus-storage facility on line, KIUC's monthly renewable production is routinely exceeding 60%; with nearly 2/3 of our evening peak load being met with stored solar power.
 - 4.5.2 The Board of Directors retired \$1.1 million in patronage capital credits to members in July.
 - 4.5.3 Endangered species protection was significantly enhanced by the installation of diverters on transmission lines throughout the island. Thanked John Cox who worked with the consultants and Cameron Kruse who worked hard to get these diverters operational.
 - 4.5.4 The KIUC website was redesigned, offering more resources and greater ease of navigation for members. Everybody seems to be very happy with the new website and thanked both Beth Tokioka and Shelly Paik and the team that worked on the project.
 - 4.5.5 A power purchase agreement between KIUC and AES for the West Kaua`i Energy Project was approved; when this new project is operational, it will meet 25% of KIUC's energy needs and bring us to more than 80% renewable generation. EarthJustice filed a Motion for Reconsideration earlier in the week and yesterday, KIUC filed a response to their Motion. Hopefully we'll get a quick resolution.
 - 4.5.6 KIUC employees and board members donated more than \$39,000, a new record, to benefit Kaua`i United Way and its partner agencies.
 - 4.5.7 KIUC was named "Electric Cooperative of the Year" by the Smart Electric Power Alliance.
 - 4.5.8 Construction of the new Anahola Service Center is substantially complete, with nearly \$8 million infused in the local economy via the two Kaua`i-based contractors.
- 4.6 2022 Preview
 - 4.6.1 Inflation, endangered species compliance, and depressed sales growth are projected to result in lower margins. A rate filing of some type will need to be evaluated.
 - 4.6.2 East Side T&D operations will move to new Anahola Service Center
 - 4.6.3 Endangered species compliance:
 - Minimization and mitigation activities will be extensive and will include starting construction of two predator proof fences
 - Draft HCP will be out for public review and potential approval late in the year
 - 4.6.4 Strategic Plan underway and hopefully it'll be completed by next year.
 - 4.6.5 WKEP will be having environmental review and land agreements will be ongoing.
 - 4.6.6 COVID-19 impacts will likely persist so we will need to continue to keep reliability and operational ability up.

- 4.6.7 Start to develop work on a new renewable energy project and some suggestions are being done at the board level of increasing our RPS target.
- 4.7 Congratulations to Director Jan TenBruggencate on receiving NRECA Director Gold Program award and President Bissell thanked Jan for continuing his education.

6. NRECA Hawaii Director Report (David Iha)

- 6.1 December Board meeting some highlights are:
 - NRECA approved the budget for next year which amounts to \$272 million dollar which supports 787 people on the payroll for two operations one in DC and one in Lincoln, Nebraska.
 - One day orientation for new directors joining the board and this year there were 11 new directors for the authorized position.
 - One of the people leaving the board is Curtis Rim, former President who accepted a CEO position in Florida.
 - Jim Matheson, CEO of NRECA, gave highlights for the year, one of which was re-engaging with staff by bringing them back to headquarters in Arlington and Lincoln.
 - NRECA is different from the other lobbying organizations in that NRECA has employees who handles the retirement system for employees with a portfolio of \$26.6 billion.
 - The 401K program has 923 co-ops which are part of that program which provides health benefits and other services.
 - Youth program seven states nationally which decided not to participate in the youth program this summer. The program will be structured differently with one group meeting one week and the other group meeting the following week, etc. Our group from Kansas which we normally coordinate with is one of the states which decided not to participate.
 - There was a long discussion on cyber security; three co-ops were hit by ransomware.
 - Some of the co-ops on the mainland are experiencing supply chain issues and the CEO of NRECA is in contact with the White House and expressing the co-ops position regarding some of those supply issue.

- Political side one of the benefits we have with the NRECA is that it's a non-partisan organization so it has support from both sides. Jim Matheson will be meeting with Nancy Pelosi and Mitch McConnell's office.
- Met Jana Adams, the new President CEO of Touchstone Energy.
- Evaluated NRECA CEO and recommended his compensation for the coming year and also looked at his plans for the program in the coming year.

Question was asked about the ransom ware attack made against the co-op and Director Iha indicated not much information was shared; however, his counterpart from California indicated his IT person was alert and disconnected their system once he saw something suspicious so they didn't lose data.

7. Charitable Foundation Board (Teofilo Tacbian)

- 7.1 Catholic Charities assisted three households for a total \$860.90. Balance is now at \$2,929.00
- 7.2 KEO assisted two households for a total of \$692.82. Balance is now at \$4,777.00.
- 7.3 Makana Program increased by three members for a total of 254 memberships so far \$2,274.64 total funds accumulated. This year PAT CAP in the amount of \$38,645.87 will be transferred to the Charitable Foundation. A check in the amount of \$5,443.00 was distributed for the Ohana Readers, the Dolly Parton program, leaving a balance \$42,306.79.






