

MEMBER PETITION FOR DIRECTOR NOMINATION FOR MARCH 18, 2023 BOARD OF DIRECTORS ELECTION

INSTRUCTIONS: All candidates must completely fill out and certify with their signature the requested information on the first page of this petition.
