### Nissan Offers Rebate to KIUC Members on 2019 and 2020 Nissan LEAF® Sedans

Līhu'e, Kaua'i, HI – 2/24/2020 – Nissan North America will continue to offer KIUC members access to rebates off the manufacturer's suggested retail price (MSRP) on the all-electric 2019 and 2020 Nissan LEAF® sedan and the 2019 and 2020 Nissan LEAF-Plus® at participating dealers through March 31, 2020.

KIUC members who buy a 2019 LEAF® can receive a \$3,500 rebate off MSRP. The rebate for the 2019 LEAF-Plus® is \$2,500. The rebate on the 2020 LEAF® is \$3,000 off MSRP, while the rebate for the 2020 LEAF-Plus® is \$2,000. Combined with \$7,500 in federal tax incentives, KIUC members could save from \$9,500 to \$11,000, depending on the model they choose.

In order to receive the rebate, KIUC members must present proof of residency, their electric bill and the Nissan flyer, which is available for download and printing from the KIUC website, <a href="www.kiuc.coop">www.kiuc.coop</a>, on the "Community" page under the "EV Resources" tab.
